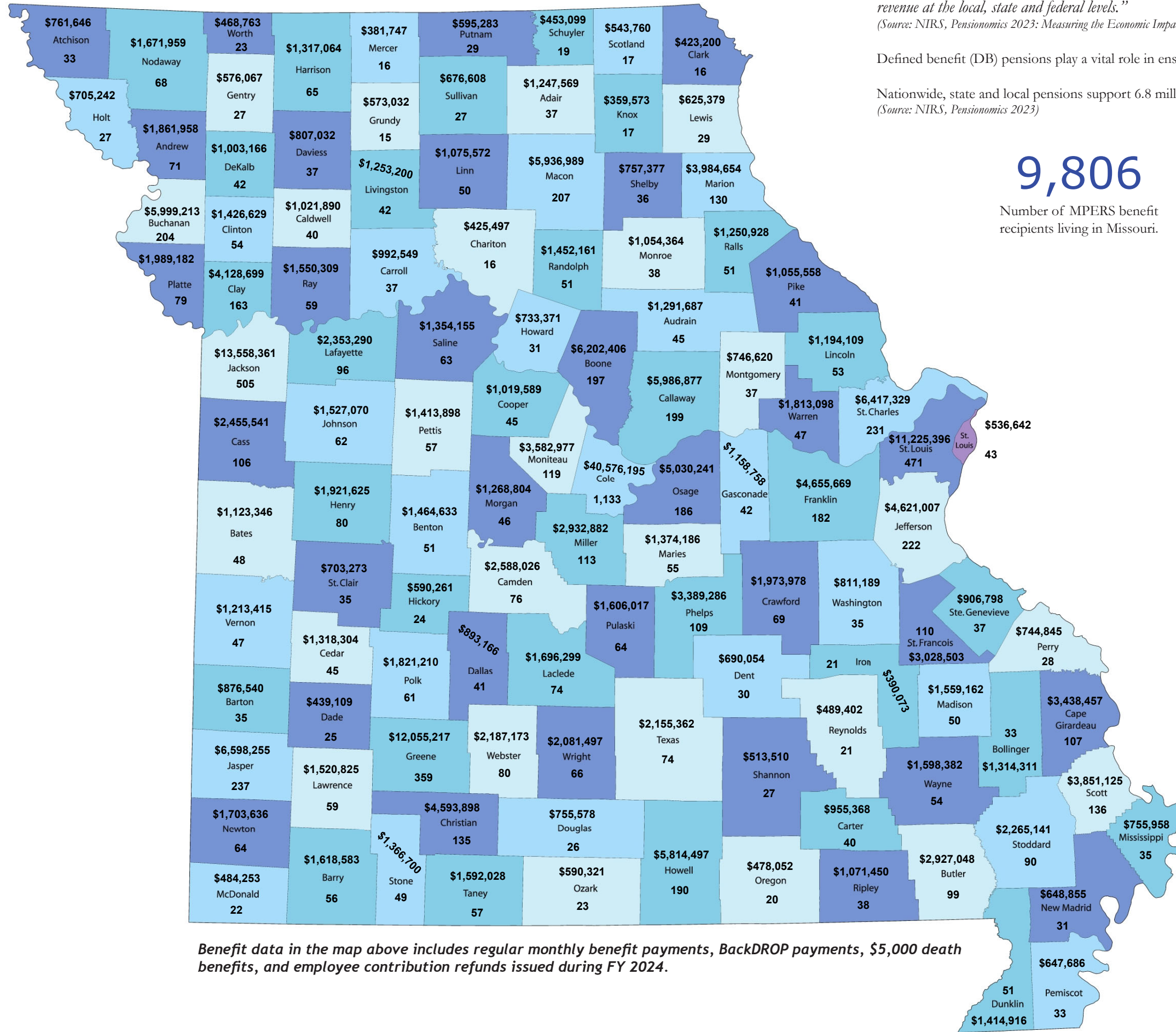


# Annual Benefits Paid to Missouri Residents Covered by MPERS



“Pension expenditures supported some 46,978 jobs in Missouri that paid \$2.44 billion in income. Pension benefits accounted for some \$7.5 billion in total economic output and \$4.3 billion in value added in Missouri. These expenditures also supported some \$157.7 billion in tax revenue at the local, state and federal levels.”

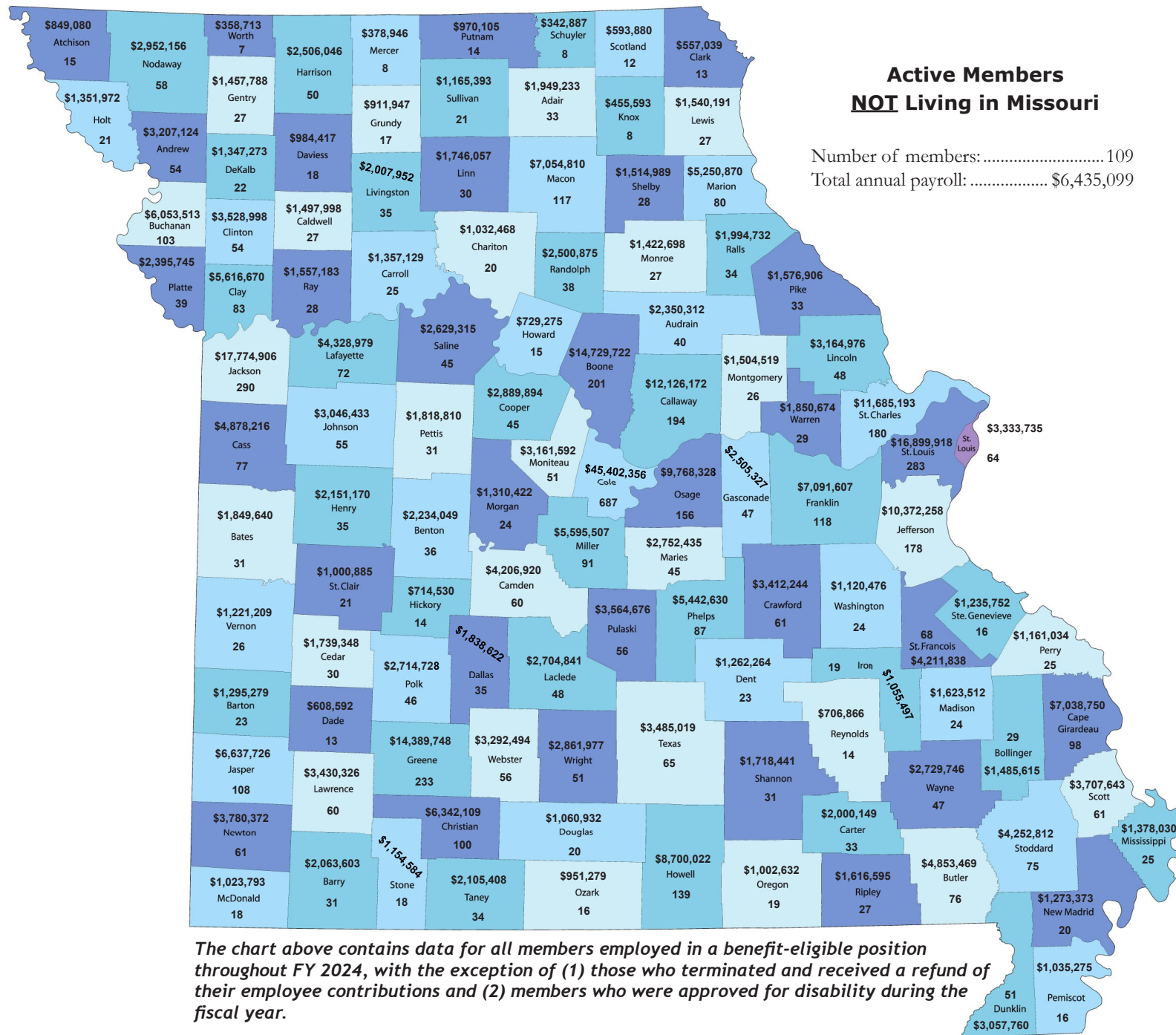
